1. Owner agrees to pay at pick-up, all scheduled fees and special request charges, any additional days will be at the rate for boarding in effect on the date pet is checked in. In the event the owner is not able to pick-up his/her pet at the scheduled time, owner agrees to pay any additional costs.
2. All Dogs and Cats must have a flea treatment prior to check-in. If Pet has not been treated for fleas and ticks, a treatment will be applied at time of check-in for an additional fee. Flea & Tick Treatment: \$ _____ Date: _____
3. All Boarding Fees are based on a 24 hour basis, if the boarding time exceeds the 24 hour period, you will be charged for a half day boarding. For instance if pet is dropped off at 8:00 am then picked up at 7:30 pm, there will be a half day charge.
4. Owner agrees to allow their pet to socialize with other pets of the same size and temperament at the discretion of the staff. The staff will monitor pets at all times while in the company of other pets and while at play.
5. If pet becomes ill or incurs an injury, every effort will be made to contact the owner or his/her agent. If no contact can be made and pet requires immediate professional attention, Your Best Friends Inn will engage the services of a Veterinarian. Owners preferred Veterinarian will be used if possible. In the event of a medical emergency, the maximum dollar amount that owner authorizes to be spent on _____ is \$ _____
